

PROPOSED PLAN REGULATION AMENDMENTS

Alberta Oat Growers Commission Plan Regulation (AR 151/2022) – Proposed Amendments

Overview

The Alberta Oat Growers Commission Plan Regulation is made by the Minister of Agriculture and Irrigation, establishes the Alberta Oat Growers Commission (AOGC), and sets the purpose, objectives, and governance framework to guide the operation of the organization.

[Alberta Oat Growers Commission Plan Regulation \(AR 151/2022\)](#) was reviewed by AOGC as required by the Alberta Agricultural Products Marketing Council mandatory regulation review policy.

The board's intent for the proposed amendments is to ensure regulations remain relevant, responsive to industry needs, align with policy, and other applicable government regulations.
